


## Legislative Roadmap


## Nationwide Waiver Authority

- Available with authority given to USDA by Congress under the Families First Coronavirus Response Act (FFCRA)
   First given March 2020
- Broad authority allowed measures that:
   Increased overall costs to the Federal Government
  - Increased overall costs to the Federal Government
    Changed meal pattern rules, eligibility, and reimbursement rates
- Last renewed in September 2021
- Expired June 30, 2022
- June 25, 2022, President Biden signed Keep Kids Fed Act providing limited extension of authority


- Temporary higher per-meal reimbursement rates in NSLP, SBP, and CACFP through June 2023

- Limited nationwide waiver authority through June 2023






#### Nationwide Waivers for Summer 2022

#### Suite of three new nationwide waivers for SFSP/SSO published June 30, 2022

- Waiver #107: Nationwide Waiver to Extend Area Eligibility Waivers for Summer 2022 Operations -EXTENSION 5
- Waiver #108: Nationwide Waiver to Allow Area Eligibility for Closed Enrolled Sites for Summer 2022 Operations – EXTENSION 4
- Waiver #109: Nationwide Waiver to Allow Summer Food Service Program Reimbursement Rates for the Seamless Summer Option in Summer 2022





## **Meal Standards**

- KKFA allows for a nationwide waiver for meal patterns
- Schools and program operators are encouraged to plan and strive for the most nutritious meals possible
- To facilitate more nutritious meals, FNS does not plan to issue a nationwide waiver of the nutrition standards for



#### Second Round of Supply Chain Assistance (SCA) Funds

- Nine hundred and forty three million (\$943M) in funding made available through the Commodity Credit Corporation (CCC) as authorized under the CCC Charter Act [15 U.S.C. 714]
- Provides an additional round of funding to address ongoing supply chain challenges experienced by school food authorities (SFAs) participating in the National School Lunch Program (NSLP) and/or School Breakfast Program (SBP)
- State agencies will distribute SCA funds to SFAs for the exclusive purchase of unprocessed and minimally processed domestic foods.
   Discretionary option to reserve some funds for State purchase of local food for distribution to SFAs.
  - of local foods for distribution to SFAs.

#### **Policy Release**

- The memorandum allocating the funds to States will be released by FNS soon.
- However, the amount of funding would be similar to the amounts allocated to States in December 2021, when FNS distributed \$1 billion in funds. 



SFAs that already signed a State-provided attestation statement to receive first round SCA funds do not need to sign another statement to receive second round funding

- All SFAs must sign an attestation for their State agency in order to receive SCA funds
   Only SFAs that did not previously sign an attestation to receive SCA funding remain subject to this requirement.
- State agencies only need to provide a simple opt-in vehicle for the second round SCA funding to SFAs that have already signed an attestation.
- The required elements of the State-provided attestation statement remains the same. Refer to policy memo SP 03-2022 for detailed guidance.

## Utilizing Food Service Management Companies and Supply Chain Assistance Funds

- SFAs that utilize FSMCs may use SCA funds to pay for unprocessed or minimally
  processed foods that are provide through FSMC contracts.
- SFA must ensure that any payments, over the period in which the SCA funds are used, include charges for unprocessed or minimally processed domestic foods at least equal to the amount of SCA funds used to pay the invoices.
- Documentation can include invoices, receipts, or statements and may take various forms and differ from traditional documentation
